- 5. The Ownership and title of Sponsorship as stated on documentation for the Nubian Goat(s) will remain in the possession of the **Sponsor** unless the **Lessee** purchases the Goat(s).
- 6. The **Sponsor** will make the Nubian Goat(s) selected available to the **Lessee** during the period of this Lease Agreement.
- 7. The **Sponsor** of the Nubian Goat(s) agrees not to hold the **Lessee** liable for any financial loss from injury or death to the leased Nubian Goat(s), except for those causes due to negligence on the part of the Lessee or by not following the maintenance schedule as determined by the Chapter AdvisorAnd **Sponsor**.
- 8. The **Sponsor** is not responsible for financial liability from any injury that the **Lessee** may incur while working with the leased Nubian Goat(s) selected.
- 9. The **Lessee** is responsible for all expenses incurred in exhibiting the Nubian Goat(s), such as veterinarian, transportation, entry fees and other expenditures.
- 10. This Lease Agreement must be signed and filed in the 4-H &/ or FFA Program Office within 14 days after completing and remain on file for the duration of this agreement.
- 11. The Lease Agreement, which includes the initial payment paid by the **Lessee**, must be signed by the **Sponsor**, **Lessee**, a parent or legal guardian of the **Lessee**, and the Chapter Advisor or as deemed appropriate by the Organization of the **Lessee**.
- 12. The **Sponsor** agrees NOT to sell the Nubian Goat(s) after signing the agreement before the end of the Lease Agreement period.
- 13. The **Lessee** must abide by all 4-H & FFA rules, policies, and requirements for specific Nubian Goat(s) projects.
